In the following pages, we demonstrate how we achieve our commitment to these youngsters. Here are just some of the highlights ahead:


- The ribbon cutting ceremony of the Culinary Learning Center was a long-awaited and pivotal moment in the Kips Bay timeline. Obesity and childhood diabetes have been challenges for youth with the highest rates being recorded in the Bronx. We knew it was necessary to enhance our health and nutrition program. With the Culinary Learning Center, we provided youngsters with the equipment and knowledge needed to not only learn healthy eating habits, but to practice them as well.
- The Emotional Wellness program is an invaluable resource addressing the mental health needs of our members. Health and Wellness Coordinator, Nilsa Rosario is committed to connecting with members in a safe space where she encourages them to express their concerns and helps them to get the proper support.

- Food insecurity has become a major concern within the communities we serve. Over 57% of members live below the poverty level. In response, Kips Bay committed to implementing food distribution days, providing bags of groceries to the community. We accomplished this in partnership with the Food Bank of NY and the NY Yankees.
- Academic achievement is a pillar of success. Kips Bay provides scholarship opportunities through the Kips Bay Scholars Fund to support members in their educational endeavors. We believe their success is our best "Return on Investment".
- During Black History month we celebrated diversity and provided a greater understanding of Black history and culture. We showcased heroes our youngsters could admire and perhaps model one day—heroes that look like them.
- With ever-increasing incidences of violence and bullying becoming a daily occurrence, Kips Bay has joined the fight against bullying. We partnered with Jake Paul and Boxing Bullies, an anti-bullying organization whose mission is to instill self-confidence, leadership, and courage through boxing.

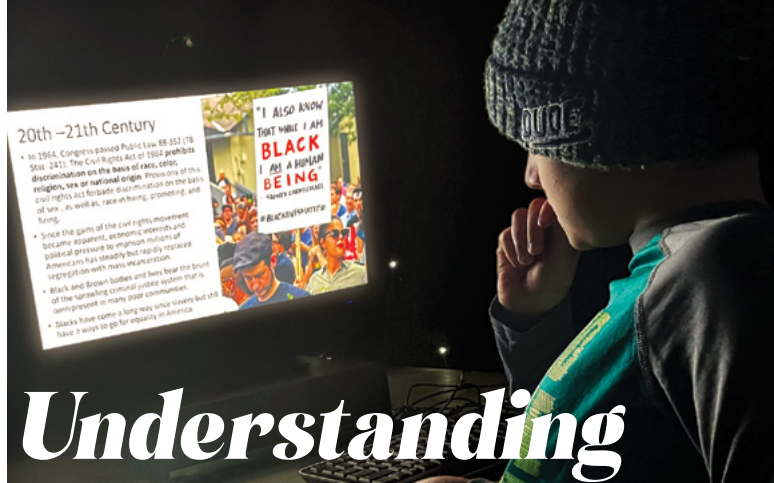

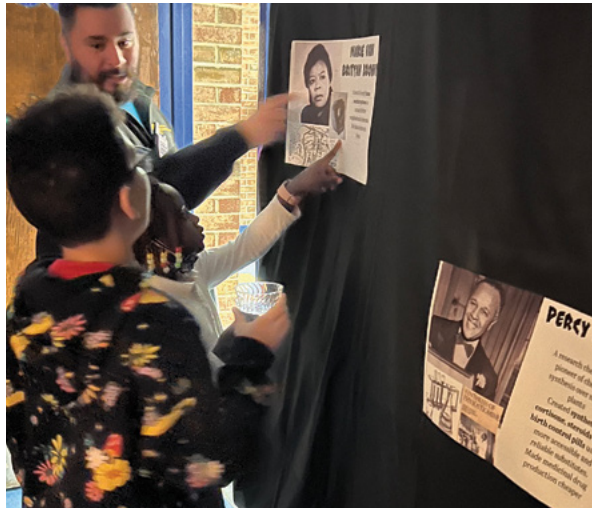
# A Greater Understanding of Black History

# Spicing up a Learning Opportunity

Members at Kips Bay have countless avenues to learn and express themselves, and one experiencing an ongoing surge in popularity is the culinary arts. Given the grim statistics of obesity and childhood diabetes in the Bronx, the need for a bigger space and updated equipment became clear. Luckily, we had the perfect spot in mind at the Coudert Clubhouse.

Understanding the value of health and nutrition education for members and their families, we approached our local city council about the need—and raised over \$1 million between city funding and private donations to build a new state-of-the-art kitchen.

In the Culinary Learning Center, members are provided the opportunity to create their own healthy dishes. Our young chefs visit the market, bring back fresh produce and other nutritious items, and prepare dishes together.

In June of 2022, we held a ribbon-cutting ceremony, and invited all those who supported the funding and creation of the new Culinary Learning Center. Interior designer and Trustee Ellie Cullman was the creative force behind the kitchen, as well as Trustee Christopher Peacock, who supported the addition of the incredible custom cabinetry. Public officials joined the festivities, including Council Member Pierina Sanchez, along with many trustees, community members and parents of Club members. Over 100 individuals helped us usher in this era in Kips Bay history that will teach members the value of nutritional cooking and healthy eating habits.

# Joining the Fight Against Bullying.

A recent large-scale study of schools revealed concerning statistics: 1 in 4 students report feeling excluded by peers and 1 in 10 report being a victim of physical bullying. Numerous other studies make it clear that everyone bullying touches—victims, bystanders, and even the bullies—are at increased risk for mental health problems. That's why we joined the fight.

Boxing Bullies is an anti-bullying organization started by Jake Paul, professional boxer, and media personality; its mission is to instill self-confidence, leadership, and courage through the sport of boxing. As more of our members began showing an interest in the sport, a partnership with Boxing Bullies made all the sense in the world.

When Jake Paul's team first visited the Club, they immediately loved the space and connected with our mission. That was in April of 2021. By November, the gym was up and running. During a visit this past year, Jake offered our members life lessons, a great workout, boxing gear—plus tickets to watch Puerto Rican boxer Amanda Serrano's fight at Madison Square Garden! Boxing Bullies is leaving a lasting impact and sends a strong message to Kips Bay kids: We're in your corner.

# Helping Our Seniors Thrive



On any given day you'll see them eating nutritious meals cooked on-site, line dancing, playing bingo, painting, jewelry making: since 2005, the primary purpose of the Kips Bay Castle Hill Senior Center remains the improvement and enhancement of the quality of life for those in our community who are 60 years of age and older.

What makes Kips Bay different from traditional senior centers, though, is the kids. We bring together generations to form our unique family. You may never see a place with such active seniors, thanks to this union.

And the seniors aren't the only ones who benefit. Intergenerational activity is a key component at the Kips Bay Castle Hill Senior Center, where kids and young staff members overlap with the senior community. With the youngest kids aged about 13 and the oldest senior clocking 102—that's a span of almost a century and all its life-changing events between them!—we've created a space essential for bringing them together in meaningful ways.

You can see eyes start opening and perspectives shifting, especially in kids who don't have other active and engaged elderly people in their lives. This is the spirit of Kips Bay—people truly and deeply connecting. We can all BE KB.

Whatever a member of our Kips Bay community experiences, a director or youth worker is always ready to listen.

“What I’m doing is making a connection with our members,” said Nilsa Rosario, Health and Wellness Coordinator at Kips Bay. “We create a safe place for the kids to talk.”

Some will need the additional support of a social worker or school psychologist, which is why we formalized the Health and Wellness Program this past year.

Of course, counseling is nothing new at Kips Bay. “We simply developed a greater capability to help and go deeper,” Nilsa adds. “This way, students get undivided attention for the period of time that they need.”

For many kids—reflecting on our wider society—counseling and therapy may have been stigmatized. The Health and Wellness Program is key to changing that perspective, making kids aware of its potential and enabling them to seek help without hesitation.

The doors of the program are always open and kids know they can freely step inside—whether it’s for an issue as urgent as self-harm or something like sorting out a career choice or a relationship issue. The program also connects kids to support groups, so they can meet with peers to build strong, positive bonds within their community.

# Always

Francesca Velez first began working at the Kips Bay summer camp when she was just 14, and “absolutely fell in love with working with the kids,” she says. In the interval between her senior year of high school and college, Francesca jumped at the chance to become a full-time staff member when a job opened up at the Kips Bay Coudert Clubhouse.

Eventually, Francesca went off to college, but she always came back to the Club, contributing to our afterschool programming. “I just really loved being with the children every day” she says. This passion compelled her to change majors to Youth and Family Studies, and upon graduation, Francesca came right back to Kips Bay, becoming the Education Director at the Kips Bay Coudert Clubhouse. “It was super hands-on,” she says. “Just working with the kids, doing homework help, building rapport with them in that way—that was my favorite part of the job.”

The kids at Kips Bay looked to Francesca as a second mom—a trusted figure and confidant. She loved hearing about their lives and her door was always open. Two years after, Francesca became the Coudert Clubhouse’s Program Director. Her professional journey was a testament to the empowering goals of Kips Bay—from camp counselor to organizational leader, managing a team of 30-plus employees and overseeing hundreds of kids.

The ultimate goal of Brent's Club is to support the development of healthy, productive, and substance-free youth. Ariel was encouraged to apply for a scholarship offered by the Club, made possible through the support of the Brent Shapiro Foundation—and this was part of her essay:

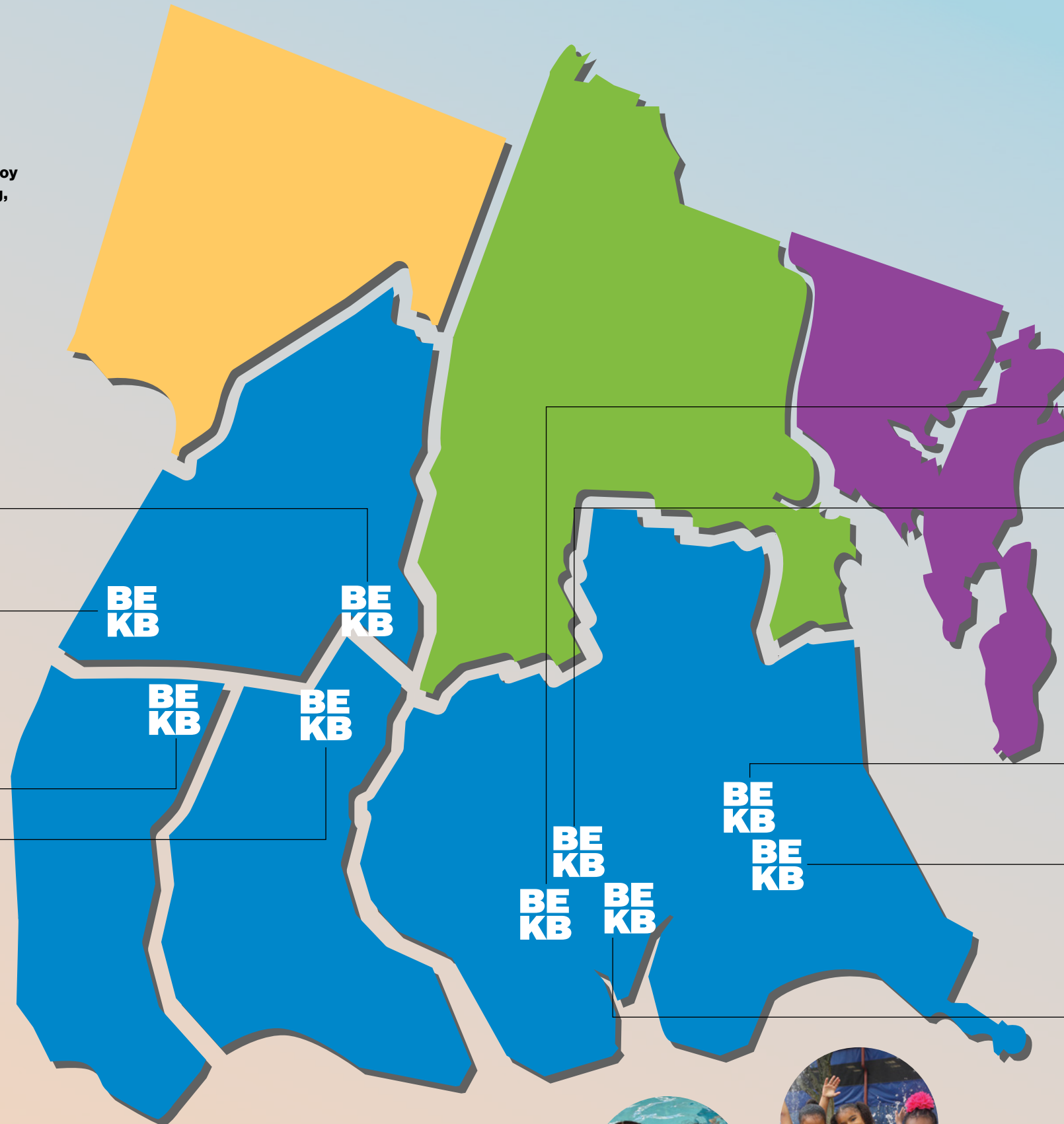

# Addressing Hunger in Our Community

Working so closely with kids each day, we've always known what the pandemic made more obvious to many: food insecurity is a reality for many families.

This year with the need so greatly magnified, we were enabled to take action. We created Food Distribution Days, providing bags of food for the communities around several Kips Bay sites. The staff worked hands-on to organize boxes, cans, and cartons, an effort made possible by donations from the New York Yankees.

Our Food Distribution Days continues; even as the pandemic subsides, food insecurity is still with us. To increase our impact, we recently created a relationship with the Food Bank of New York, with the goal of organizing Food Distribution Days at least once every month, allowing us to meet the needs of the families right where they live.

Days like these are a firm reminder that the Kips Bay Boys & Girls Club is about so much more than its programming and activities. Our mission is to enhance the quality of life of families in our community, in every way—including the moms, dads, brothers, and sisters of our members. ## ***Dennis Hersch— Generosity and Spirit***

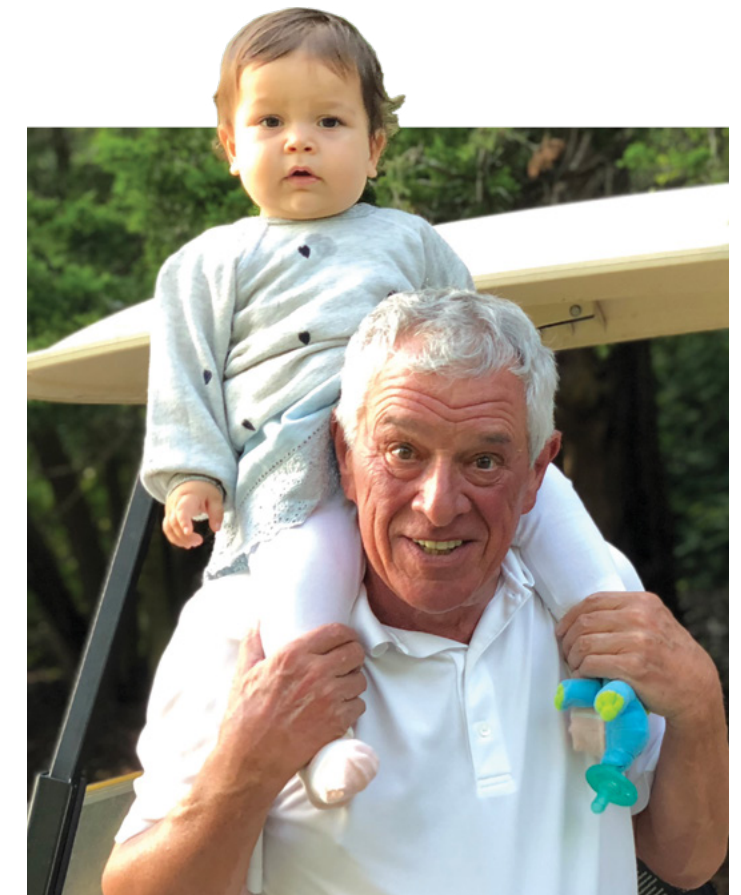

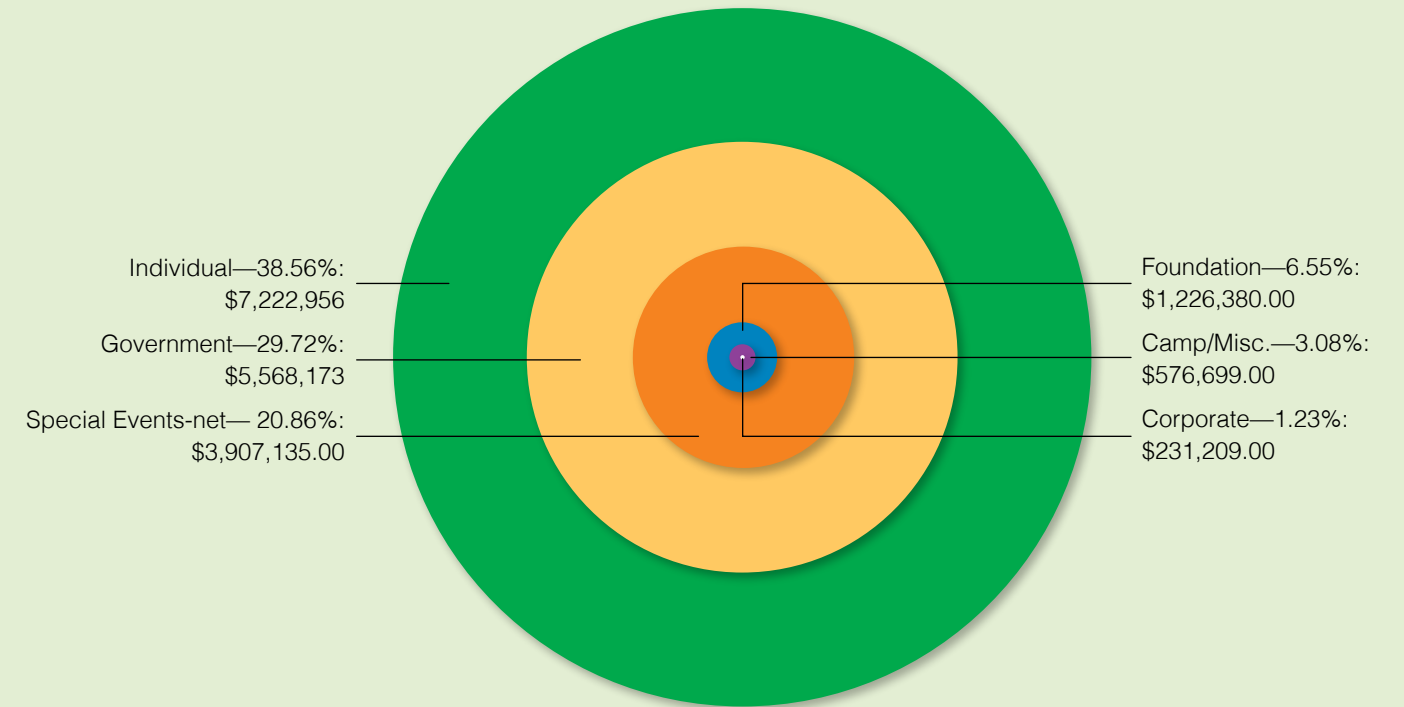

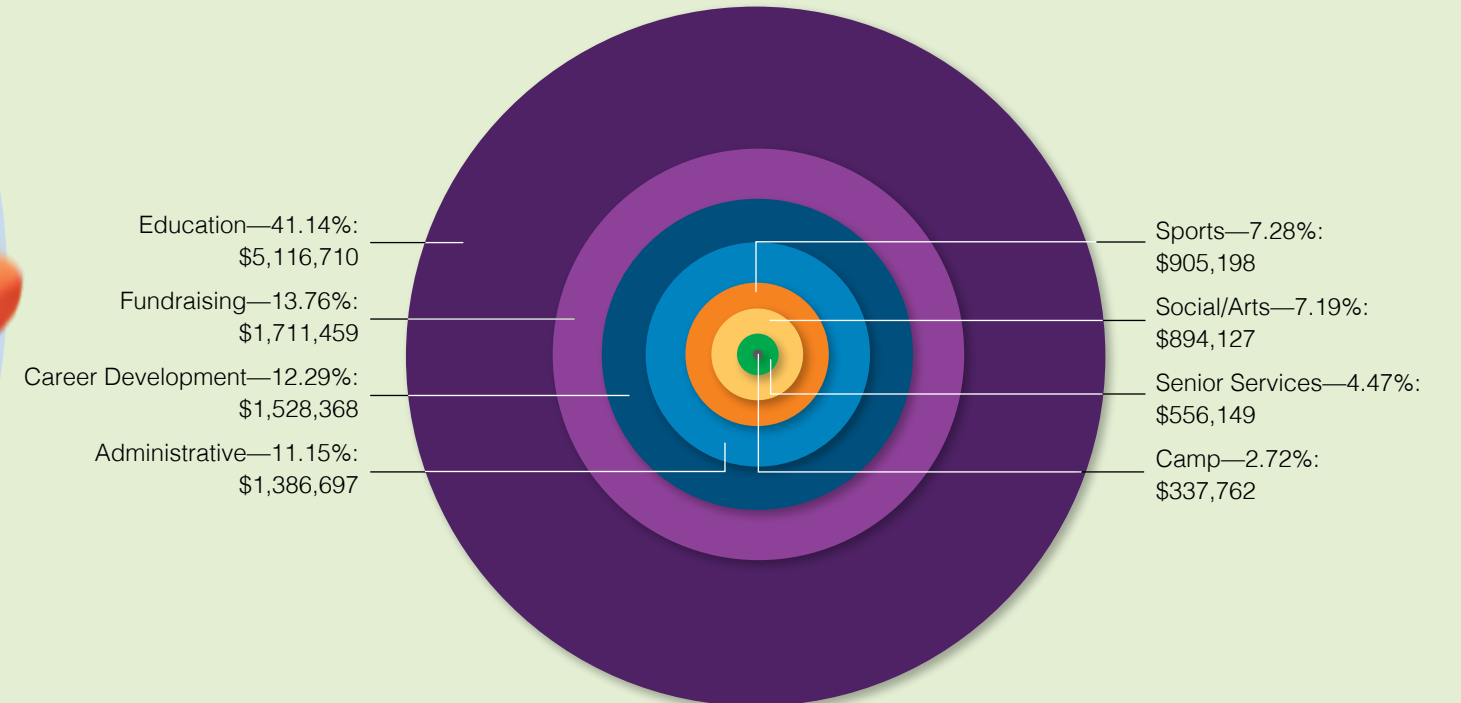


# Financial Summary 2022

The accounts of Kips Bay Boys & Girls Club, Inc. for fiscal year 2022 have been audited by Forvis, LLP, Certified Public Accountants.
